Transport, logistics and infrastructure. Both Parties share a common vision about the improvement of accessible, safe, inclusive and sustainable transport.

The Parties will cooperate in the development of infrastructure connectivity, including financing, interoperability and logistics, in areas of mutual interest (such as roads, railways, bridges, civil aviation, ports, energy – including renewables and natural gas - and telecommunications).


The Parties express their interest in developing synergies between the Belt and Road Initiative, the Italian system of transport and infrastructure, such as -inter alia- roads, railways, bridges, civil aviation and ports and the EU Trans-European Transport Network (TEN-T).

The Parties welcome the discussions in the framework of the EU-China Connectivity Platform to improve the efficiency of the connectivity between Europe and China.

The Parties will cooperate in facilitating customs clearance, strengthening co-operation in sustainable, safe and digital transport solutions as well as in their investments and financing. The Parties highlight the importance of open, transparent, and non-discriminatory procurement procedures.

The **Ligue**, supports the decision of M5S as part of the same Government, but now is the new right wing Government.


Fratelli D'Italia is the most important party after the election in 2023. It is a conservative party with a very strong connexion.


Export-Import Italy to/from China (bln of Euro)












Rail freight modal share





Italian Rail freight Sector






